  - (b) \_\_\_\_\_ Consistency of the proposed amendment with the goals and policies of the General Plan.
  - (c) \_\_\_\_\_ Compatibility of the proposed land use with the existing land uses of nearby and adjoining properties.
  - (d) \_\_\_\_\_ The effect of the proposed amendment on the character of the surrounding area, and whether a change in the uses allowed for the affected properties will unduly affect the uses, or proposed uses for nearby and adjoining properties;
  - (e) \_\_\_\_\_ The gain to the public health, safety and welfare and overall community benefit from the existing classification to the proposed amendment..
  
- (2) \_\_\_\_\_ A map showing the location of the subject property and any other pictures (aerial photos etc.), studies, or supporting documentation that would allow the City Council to make a well-informed decision.
  
- (3) \_\_\_\_\_ As a courtesy to property owners, all applicants for a Zoning Map Amendment shall provide the City with stamped and preaddressed envelopes (#10 business size) for each owner of record of each parcel located entirely or partly within three hundred (300) feet from any boundary of the property subject to the application, including any owners of property in unincorporated Utah County or adjacent municipalities, together with a **mailing list for those owners**. The names and addresses shall be as shown on the most recently available Utah County tax assessment rolls. It shall be the sole responsibility of the applicant to verify that the mailing list and envelopes are complete and accurate.
