1. DISCUSSION OF THE MIXED USE ZONE ON MAIN STREET.

Discussed what needs to be done to make Main Street more welcoming and walk-able.

Doug Meldrum mentioned that there are some obstacles in the down town area; the biggest being the traffic. The only way to alleviate that is to change the traffic situation; have destination shopping. The City has invested in the downtown area. He said maybe we need to open up across the street so the Legacy Center is more visible. Maybe start on the south side of the street and decide what you want to see there; the seating, the garbage, etc. so if there is a change in the downtown buildings you have something to change it to. Maybe we need to create an RDA but you can't start that without having a plan.
