Performs a variety of "lead" **paramedic certified and advanced level firefighting duties** related to protecting life and property of city residents. Must be able to drive and operate all types of medical/fire apparatus.

## SUPERVISION RECEIVED

Works under the close supervision of the Captain or designated shift supervisor.

# SUPERVISION EXERCISED

Provides immediate to close supervision to Firefighter/Paramedic, Fire Fighter/EMT-A, EMT students, and Paramedic interns while in training or on emergency calls and on a project-by-project basis. In the absence of a higher ranking officer acts as Incident Commander.

#### ESSENTIAL FUNCTIONS

<u>Paramedic</u>: Performs various lead worker duties; assists to coordinate and schedule continuing education programs, workshops and seminars consistent with Paramedic certification requirements; coordinates with state regulatory agencies as needed; provides mentoring supervision to less experienced EMT personnel; may assist to evaluate EMT-B and EMT-A performance; may make recommendations affecting employment status, i.e., retention, advancement, discipline or discharge. Must have current ACLC, PALS, and BLS certifications.

Responds to emergency medical calls; assumes full responsibility for medical patients requiring critical care; utilizes radio communications to receive and transmit communications; operates ambulance under emergency conditions and normal conditions to transport accident victims and emergency medical patients to health care facilities, hospitals or other institutions.

Evaluates patient's condition and/or injuries at accident scenes and/or medical emergencies and administers aid as per protocol; monitors patient's vital signs and provides basic and advanced life support until transported to hospital; completes written and computerized medical documents and submits them to appropriate locations.

Performs advanced life support procedures such as direct larynogoscopy, endotracheal intubation (orotrachael & nasotracheal), endotrachael suctioning, surgical cricothyrotomy, needle thoracostomy, ECG interpretation, synchronized cardioversion, defibrillation, transcutaneous cardiac pacing; administers advanced medications i.e., anti-arrhythmics, albuterol, atropine, dextrose (oral and injectable), nitroglycerine, vasopressors, , midazolam, diazepam, etc.; utilizes various advanced routes for medication administration, i.e., endotrachael, intradermal, intramuscular, intraosseous, intravenous, nebulized aerosol, parenteral, rectal, subcutaneous, sublingual, topical, etc.; performs or assists to perform various rescues including rope rescue, trench rescue, ice rescue, confined space rescue, collapse rescue; vehicle extrications, etc.

Performs intermediate level emergency medical procedures such as, subcutaneous injections, intravenous injections, nebulized inhalations, intradermal biological testing, and immunological vaccination administrations; administers various advanced levels of medications, i.e., epinephrine, NTG, fentanyl, morphine, glucagon, diphenhydramine, etc. Operates resuscitation and suction devices during cardiopulmonary resuscitation; applies traction splints, cervical collars, backboards, and various other medical devices used to immobilize patients during transport and extrication.

Applies bandages and dressing on soft tissue injuries as needed to stop bleeding; lifts and carries patients from scene to ambulance according to established procedures; performs various basic lifesaving procedures such as End Tidal Co2 monitoring, pulse oximetry, blood glucometry, oxygen administration, splinting, oropharyngeal and nasopharyngeal airway placement, supraglottic tube placement, semi-automatic defibrillation, oral glucose administration, and approved chemical/medication administrations, etc.; assists with emergency child birth; birth; provides intra-facility transports requiring use of ventilators and dripsets.

<u>Firefighter</u>: Receives continuous classroom and field training in a wide range of fire prevention, Paramedic, and firefighting techniques, principles, and procedures; receives specialized training in salvage and rescue operation, emergency medical aid, Homeland security, hazardous materials, disaster, drowning, and other related emergency situations; participates in drills.

Responds to fire alarm signals; performs as member of firefighting team; responds to emergency calls by riding medical/fire apparatus to scene of fire; manipulates various sized appliances, nozzles, hose streams; lays and connects water hose, hooks up pump, holds nozzle and directs water stream; raises and climbs ladders and utilizes other specialized equipment such as chemical

fire extinguisher, SCBA's, encapsulated chemical suits, power saws; operates extension ladders in actual rescue situations and in regular training; uses various hand tools such as rope, axes, etc.

Receives instruction on policies and procedures to conduct fire prevention inspections on various types of facilities; conducts inspections and advises resident or owner of necessary action to conform to standards; assists in performing fire scene investigations to determine "point of origin" and cause of fires; prepares and submits a variety of reports related to inspection activity.

<u>Public Relations</u>: participates in making public presentations in schools, Boy Scout units, etc. to promote fire hazard awareness and fire prevention; acts as a CPR instructor for classes to the general public

<u>General Operations</u>: Performs computer data entry to document shift activities; performs various station house maintenance duties; cleans facilities and apparatus; assists with hydrant and medical equipment inventory control; conducts pre-run and post-run inspections; conducts flush tests on hydrants and performs needed maintenance; provides peer support in response to "coping calls".

Performs related duties as required.

### MINIMUM QUALIFICATIONS

- 1. Education and Experience:
  - A. Graduation from high school, or equivalent; plus Utah State Bureau of EMS Paramedic Certification;

AND

B. Four (4) years of full time work experience as a Fire Fighter; One (1) year of which as a Paramedic;

OR

- C. An equivalent combination of education and experience.
- 2. Knowledge, Skills, and Abilities:

Considerable knowledge of first-aid and emergency medical techniques and procedures; emergency vehicle operation; various medical procedures necessary to sustain and prolong life in the absence of a medical doctor; medical terminology; various effects of medications or the lack of the same leading to life threatening conditions firefighting methods, techniques, and procedures; firefighting equipment types and varieties and their most appropriate and effective use; equipment maintenance and care; state and city codes, laws, and regulations, and ordinances related to fire prevention; fire vehicle equipment; emergency medical techniques and procedures and first-aid; interpersonal communication skills; city geography, road system and related GIS mapping resources. Some knowledge of training methods and techniques.

**Considerable skill** required for effective communications during high stress emergency medical situations including the general public and medical professionals.

**Ability to** follow detailed verbal or written work instructions; work in dangerous emergency situations; perform strenuous physical labor; communicate effectively, verbally and in writing; assimilate modern fire prevention and firefighting skills; perform under extreme weather conditions; work on call and on shift work; develop effective working relationships with supervisors, fellow employees, and the public.

- 4. Must possess a valid Utah State Driver's License. Must be certified as Utah State Bureau of EMS Paramedic. Must be certified as a Utah State firefighter 1 and 2. Must obtain A.D.O.-pumper and aerial within one year from hire date. Must obtain NWCG red card certification within one year from hire date. Must complete computer based NIMS training and obtain NIMS 100, 200, 700, 800 certification six months from hire date. Must become "Wildland" certified. Work Environment:

Functions of the position generally performed in a controlled environment, but subject to all seasonal and weather extremes. Emergency response travel expected in normal course of performing duties. Many functions of the work pose high degree of hazard uncertainty. Physical readiness and conditioning may be a condition of job retention. Various levels of mental application required, i.e. memory for details, emotional stability, critical thinking, creative problem solving. Continuous use of motor skills. Duties require lifting 80-100 pounds.
