The applicant shall create an account and submit all required information electronically through the following ling https://www.lehi-ut.gov/government/public-meetings/planning/applications/ (Agency Code Leh02), including Staff will then review the submittal and send out an email with a link for the payment of fees.  The applicant shall provide stamped, addressed #10 business envelopes for all property owners within 300 fee				
including a mailing list.  The names and addresses for the most recently available Utah County tax assessment records can be found by using the following link <a href="https://maps.utahcounty.gov/PropertyNotification/PropertyNotification.htm">https://maps.utahcounty.gov/PropertyNotification/PropertyNotification.htm</a> . It shall be the sole responsibility of the applicant to verify that the mailing list and envelopes are complete and accurate.				
The deadline for submittal for the meeting of the Reviewing Departments is 5:00 pm on Tuesday for review the following week on Wednesday. All fees need to be paid by noon on Wednesday (a week before the meeting). It is the applicant's responsibility to call and confirm their scheduled DRC time.
