CONSUMER RESPONSIBILITY

PAYMENT The applicant agrees to pay monthly for the utility services rendered by Lehi City. Services generally include electric, water, sewer, pressurized irrigation, storm drainage, and garbage. Charges for services will be made at the regularly established rates for the class of service applicable to the applicant. It is the consumer's responsibility to review the monthly bills for accuracy and notify the City of any concerns. _____initial

DELINQUENCY Payment for services is due immediately upon billing and shall be delinquent if not paid by the due date on the bill. A penalty of 1.5% per month will be added to the delinquent account. The City may disconnect service on delinquent accounts not paid five (5) days after due date. City shall not be liable for any damage resulting from such disconnection. Customer must bring current all delinquent charges as well as pay the reconnection fee prior to services being restored. Consumer agrees to pay reasonable expenses of collection, including attorney's fees and court costs, incurred in collecting applicant's terminated account.

REASONABLE ACCESS The applicant shall permit the City's authorized representatives to enter on the consumer's premises at all reasonable times for purposes connected with rendering, billing, or disconnecting utility services.

TERMINATION OF SERVICE The applicant agrees to be responsible for the payment of utility charges incurred at these premises until their responsibility is terminated in one of the following ways:

1. By verbal or written order by the applicant.
2. By the City's termination for lack of payment, as outlined previously.
3. Upon completion of an application for services, at the location, by another party.

The City shall use reasonable diligence to provide constant and uninterrupted services to the consumer, but if such services shall fail or be interrupted or become irregular through any cause beyond the reasonable control of the City, the City shall not be liable for any damages resulting from such failure, interruption or irregularity. The consumer agrees to the above terms and conditions and agrees to be bound by the Rules and Regulations adapted from time to time by Lehi City, and acknowledges that each of the undersigned has joint and several liability to the City for all obligations incurred at the location during the term of the contract.

Applicant warrants that all information supplied in this contract is true and correct and understands that false and misleading information shall be cause for the City to deny or cancel service and demand immediate payment of any amounts due.
