- Notes:
1. Connection to the City sewer is required if City lines are within 300 feet of any part of the subject lot. Add an additional 150 feet for each lot in the subdivision. Lots, which are not required to connect to the City sewer system, must comply with the applicable State and County regulations prior to applying to Lehi City.
  2. The developer is required to install sewer main lines with service laterals to each lot in any new street regardless of whether or not connection to the City sewer system is required.
  3. Required if City main lines are within 500 feet of any part of the subject lot. Add an additional 250 feet for each lot in the subdivision.
  4. (DSPIS) = Lehi City Design Standards and Public Improvement Specifications.
  5. No construction is allowed in areas designated for future roads in Master Transportation Plan or trails in the Parks and Trails Master Plan.
  6. Escrow or Letter of Credit Bond and Public Improvement Agreement are required for all public and private improvements per Section 11.220.
