As Utah's sixth oldest city, Lehi is rich in pioneer and old west history. Originally settled by Mormon pioneers, Lehi City has been known as Sulphur Springs, Snow's springs, Dry Creek and Evansville. It was incorporated as Lehi City in 1852.

### About Lehi City




#### Lehi City Population







## Patrol Division

The Patrol Division is the largest and most visible division within the Lehi Police Department. There are currently 35 sworn officers in the Patrol Division. Patrol Officers are assigned to Patrol Teams. Each team is supervised by a Sergeant who in turn reports to a Patrol Lieutenant.

Patrol Officers wear specific patrol uniforms and drive marked patrol vehicles. Patrol Officers are primarily first responders, responsible for providing 24-hour police services. Lehi Patrol Officers are dedicated police professionals committed to serving our community by:

- Responding to 911 emergency calls
- Responding to non-emergency calls
- Proactively patrolling Lehi City
- Traffic accident investigations
- Traffic enforcement & DUI detection

In addition to the duties listed above, officers in the patrol division also participate in various specialized assignments to enhance the level of police service to our community such as:

In addition to our full-time patrol officers, the Lehi Police Department maintains a pool of part-time/reserve officers. These officers are used to supplement the Patrol Division by providing additional manpower during scheduling shortages




## Patrol Division Calls for Service



**Public Generated Calls:** calls for service dispatched through Central 911:




**Calls for Service by Time Reported****Calls Reported by Day of Week**




**Total Traffic Stops**



### Patrol Division Traffic Enforcement—DUI & Alcohol Offenses




In 2020, officers made **98** DUI and **102** other alcohol related arrests.

In addition, there were **164** alcohol related incidents in which no arrests were made.


### DUI & Other Alcohol Offenses






■ Injury Accidents ■ Hit & Run ■ Damage Only


Officer T. Peterson oversees our Animal Services. In addition to responding to calls for service, he also works closely with City Administration to ensure our animal codes and ordinances are current.

### Investigations Division

The Investigations Division consists of 12 officers who are responsible for conducting ongoing investigations. Investigators are assigned to specialized teams supervised by a Sergeant, who in turn reports to a Lieutenant.

The investigative teams include:

- Special Enforcement Team
- Property Crimes
- School Resource Officers
- Special Victims Unit


Criteria for assigning a case to the Investigation Division is based upon several factors including, but not limited to the type of crime, severity of crime, the need for on-going or additional follow-up.

Once a case has been assigned to the investigation's division, the assigned investigator's responsibilities include:

- Interviewing victims, witnesses and potential suspects of crime
- Crime scene management (identifying, collecting, documenting, and preserving evidence of crime)
- Collaborating and coordinating investigations with various federal, state, and county agencies
- Working with prosecutors and courts to secure subpoenas, summons, and warrants

The Professional Standards Division consists of 4 officers and 10 civilian staff members. The division reports to a Lieutenant. The division is responsible for:

- Maintaining officer in-service training records
- Conducting internal investigations
- Coordinating Victim Services
- Securing and maintaining evidence
- Maintaining and disseminating police records
- Providing Lehi City Justice Court Security
- Overseeing the Lehi Police Department Volunteer Program


Victim Services is designed to break the cycle of violence and to help victims become abuse-free and independent. The main objective is to help victims:




### Crime Data—UCR Part I Crimes




