

RESOLUTION NO: 2021-62

A RESOLUTION OF THE BOARD OF CANVASSERS CERTIFYING THE OFFICIAL CANVASSERS' REPORT OF THE NOVEMBER 2, 2021 GENERAL MUNICIPAL ELECTION FOR LEHI CITY, UTAH.

WHEREAS, on November 2, 2021, a General Municipal Election for Lehi City, Utah was held to elect a Mayor and two City Council candidates with the most votes; and

WHEREAS, this election was conducted by Lehi City through Ranked Choice Vote by Mail and administered by Utah County. Those results pertaining specifically to Lehi City's municipal election are included in this official canvass report.

WHEREAS, UCA 20A-4-301(2) provides as follows:

- 2(a) The Mayor and the municipal legislative body are the board of municipal canvassers for the municipality.
- (b) The board of municipal canvassers shall meet to canvass the returns at the usual place of meeting of the municipal legislative body:
 - (i) for canvassing of returns from a municipal primary election, no sooner than seven days after the election and no later than 14 days after the election;
- (c) Attendance of a simple majority of the municipal legislative body shall constitute a quorum for conducting the canvass.

The official results are attached as Exhibit A

Mayor Candidate Mark Johnson received the highest number of votes using the Ranked Choice Voting method in this General Municipal Election, and is hereby declared duly elected for the office of Mayor, for a term of four years.

City Council Candidates Chris Condie and Paul Hancock received the highest number of votes using the Ranked Choice Voting method in this General Municipal Election, and are hereby declared duly elected for the office of City Council, for a term of four years.
