# Lehi Senior Center Membership Holders Agreement

## DEFINITIONS

In exchange for my membership in the Lehi City Senior Center ("Senior Center"), and for allowing me to participate in the Senior Center's recreational activities, including, but not limited to, any field trips in which I may participate, as well as the use of Lehi City's ("City") properties, facilities, and services related to said recreational activities (collectively, "Activities"), I agree to the following:

1. My participation in the Activities involve certain inherent physical and emotional risks, and I assume full responsibility for any personal injury to myself.
2. For myself, and on behalf of my family, heirs, executors, and administrators, I hereby release and discharge the City and the Senior Center, their volunteers, employees, officers, and elected and appointed officials from any injury, loss, damage, or other liability associated in any way with my participation in the Activities, which may be caused by the negligent acts of the City or the Senior Center, their volunteers, employees, officers, or elected and appointed officials.
3. I will indemnify and defend the City and the Senior Center, their volunteers, employees, officers, and elected and appointed officials, against all claims, causes of action, damages, judgments, costs or expenses, including, but not limited to, attorney fees and other litigation costs, which are associated in any way with my participation in the Activities.
4. I will obey all rules and warnings posted by the City or the Senior Center during my participation in the Activities, as well as any verbal instructions given by the City or the Senior Center, or their employees during said Activities. Furthermore, I will take full responsibility and liability for all of my actions while participating in the Activities.
5. In the event of an emergency, I authorize the City and the Senior Center to act on my behalf, in their best judgment, to obtain medical treatment. I further agree to assume full responsibility and liability for any associated expenses that may arise during my participation in the Activities.
6. As a participant in the Activities, the City and Senior Center may take photographs or video of me during such participation. I hereby allow any such photo, video, or other likeness of me, to be used by the City for promotional or advertising purposes.
7. Any legal or equitable claim associated in any way with this agreement, including, but not limited to, my participation in the Activities, shall be resolved under Utah law and in the courts located in Utah County, Utah.

## RULES & REGULATIONS

1. **Membership, Activity, and Field Trip Sales.** All sales are final, non-transferable, and non-assignable. Refunds are available only under emergency or unpredictable circumstances.
2. **Membership Holder Entitlements.** All membership holders are entitled to use the cardio/billiard room, TV room, piano, and many of the classes for no additional charge. Charges for some Activities are not included in the normal membership fee.
3. **Membership Cards.** Cards are issued to all membership holders.
4. **Age Requirements.** The Senior Center membership applies to adults 60 and older. Anyone under the age of 60 will be required to pay an additional fee to participate in senior center Activities. The Senior Center reserves the right to refuse registration to those under the age of 60, if registration in Activities is limited for specified reasons. Priority registration will go to seniors.
5. **Operation Hours.** The Senior Center is open Mon-Thurs from 7am-3pm, and Fridays from 7am-2pm. The Center may be subject to different hours according to programming; all hours are subject to changes without prior notice.
6. **Pass Holder Conduct.** Any pass holder who does not comply with the rules of the Senior Center, or who shall conduct himself or herself in any unbecoming manner may be expelled and/or have their pass revoked.
