POSITION SUMMARY

Performs a variety of **entry level, semi-skilled and unskilled duties** related to the construction, installation, maintenance and repair of city electrical power system.

ESSENTIAL FUNCTIONS

Assists electrical power crews pulling, splicing, and terminating de-energized power cables. Labels wire direction. Framing and preparing wooden poles and overhead power line structures; pre-assembles switches and ground sleeves.

Setting wooden poles and stringing de-energized conductors. Loads wire reels, transformer, wooden poles, street light poles and other electrical hardware and materials for transportation to job sites.

Assists lineman in troubleshooting, phasing, erecting, demolition, calibrating, shoveling, street lighting, power restoration, equipment maintenance, tree trimming, Christmas decorations, meter installations, substation work, transformer installations, conduit installation, etc.

Operates a variety of equipment such as backhoe, forklift, line truck, bucket truck, boom truck and wire puller.

Operates a variety of hand tools and small power equipment such as jack hammers, roller, compressors, packing machine, gopher, tamper, tapping machine; cleans tools and equipment to assure proper working order.

Conducts street light audits, identifies malfunctioning lights; repairs and/or replaces light to restore proper function; may work on hot or cold lights; assists in the construction of school crossing lights.

May assist as a meter reader; may assist with service "turn-on" or "shut-off" assignments.

Performs related duties as required.
